Chemicals used in industry, science, photography, agriculture, horticulture and forestry...

Unprocessed artificial resins and unprocessed plastics...

Manures and soils...

CLASS 2

Paints, varnishes, lacquers, anti-rust, preservatives against deterioration of wood, binding substances and thinners for paints; paint pigments, preservatives for metal; shoe paints; print paints and inks, toners; substances for coloring foodstuffs, pharmaceutical products and beverages...

Metal materials for sieving, filtering and similar purposes...

Metal doors and windows, rolling shutters, Venetian blinds, cases and arms thereof (except locks)...

Metal cables and wires not for electrical purposes...

Ironmongery (hardware) articles...

Airing canals, holes, hole covers, anemostads, pipes, chimney heads, manholes (stack) covers, grills for ventilating, heating, canalization, telephone, underground electricity and air-conditioning installations...

Metal materials for pointing, navigating, indicating, introduction purposes (including sign boards, panels, plates)...

Metal pipes for liquid or gas transfer and their connection parts (including drilling pipes)...

Metal safes...

Railway materials made of metal...

Metal crown posts and floats, metal pontoons, anchors for sea vehicles...

Metal moulds for casting (other than machine parts)...

Works of art made of common metals and their alloys...

CLASS 7

Machines and machine tools for processing and shaping of wood, metal, glass and plastic materials and metals and industrial robots for those purposes...

Working machines and robotic mechanisms of the same function...

Lifting, carrying and transferring machines, robotic mechanisms of the same function (including elevators, escalators, cranes)...

Machines and robotic mechanisms used in agriculture, animal breeding, agricultural sectors and cereals/fruit/vegetable/food processing...

Engines, electrical engines other than for land vehicles and parts and equipments thereof...

Bearings, ball or cop bearings...

Wheel removing and mounting machines...

Alternators, generators, electricity generators, generators driven by solar energy...

Painting machines, automated paint injection guns, electric staple machines and guns, electric adhesive guns, pressured air or liquid atomizers (guns) for machines, manual electric drillers, manual motor saws, decoupage machines, spiral machines, pressured air producers, compressors, vehicle washing machines and robots of the same functioning with machines and apparatus listed above...

Welding machines and robots of the same function...

Packaging machines, filling-plugging and closing machines, labeling machines, classification machines and robots and robotic mechanisms of the same function with the above listed machines...

Electric apparatus used in the kitchen for chopping, grinding, crushing, mixing and crumbling; washing machines (including laundry washing/dish washing machines); electrical machines for cleaning floors, carpet or upholstery, electrical vacuum cleaners and parts thereof...

CLASS 8

Forks, spoons, knives including those made-of precious metals and non-electrical cutting kitchen tools for cutting, slicing, peeling...

Cutting and provoking weapons...

Tools and devices (including scissors) used for personal care for shaving, depilation, manicure, pedicure and beauty purposes included in this class...

Hand operated (non-motor) tools related to repairing of machines, devices, vehicles and related to construction, agriculture, horticulture and forestry...

CLASS 9

Measurement tools, devices, indicators including those for scientific purposes and laboratory use and materials used in laboratories...

Devices for recording, transmission or reproduction of sound and images (including devices, computers, software and computer peripherals for data processing, communicating and reproduction purposes)...

Record carriers in form of magnetic, optical or exposed film...

Antennas, satellite antennas, amplifiers and parts thereof...

Automatic vending machines, ticket automates, cash machines...

Electronic elements used in machines and devices...

Counters and timers measuring the consumption amounts in unit times...

Protective clothing, equipment for protection and life rescuing purposes...

Glasses, sunglasses, lenses and their boxes, cases, parts and accessories...

Electrical energy transmission, transformation, storing control devices and apparatus (including cables and power supplies used in electricity and electronics)...

Devices with warning and alarm functions mainly (other than vehicle alarms), electric bells...

Irons; electric irons and steam irons, press irons...

Signalization, pointing devices and apparatus for use in traffic...

Fire extinguishing tools and devices including fire-extinguishing vehicles...

Electrical welding apparatus (including welding electrodes)...

Radars, submarine radars (sonars), night vision providing or enhancing devices and apparatus...

Electric devices for destroying or repelling flies and insects...

Automatic doors, automatic tourniquets for buildings and electric, electronic or remote controlled opening-closing installations for buildings and vehicle doors...

Apparatus for electrolysis and galvanization; anodes, cathodes...

Magnets, decorative magnets...

Surgical, medical, dental and veterinary apparatus, devices and furniture...

Artificial organs and prostheses...

Medical orthopedic materials...

Clothing for surgery and sterile covers...

Apparatus and materials for sexual purposes...

Apparatus for heating and steam production installations (including solid, liquid, gas fuel and electric stoves, cook stoves)...

Acclimatization and ventilating devices...

Cooling and freezing devices...

Electric and gas apparatus, machines and devices (including laundry drying machines, hair dryers and hand drying devices) used for cooking, drying and boiling (including for personal use)...

Sanitary installation, vitrified materials...

Water softening apparatus, water-purifying apparatus, water purifying installations, sewage purifying installations...

Electrical coverlets and electrical quilts not for medical purposes, heating pillows, electrical or non-electrical foot heaters, hot water bags (thermophors)...

Filters and filter-motor combinations for aquariums...

Industrial type cooking, drying and cooling installations...

Pasteurizing and sterilizing machines...

CLASS 12

Motor land vehicles and motors and their parts (including motorcycles and mopeds)...

Bicycles and their bodies, handle bars, fenders...

Vehicle cases, dump cases, tractor trailers, frigorific cases, trailer connections, dampers for vehicles, lifting equipments...

Vehicle seats, head supports for seats, safe child seats, seat coverings, car covers (with designs), sun visors...

Signals and direction arms for signaling; windshield wipers, arms for windshield wipers...

Tire tubes and tire covers, tubeless tires for vehicles, tire repair sets, vehicle tire patches, weld patches, valves for vehicle tires...

Glasses for vehicles, safe vehicle glasses, rear view mirrors and side-mirrors for vehicles...

Chains for anti-skidding, skids...

Luggage carriers for vehicles, bicycle and ski carriers, saddles...

Tire inflating pumps...

Burglar alarms, horns for vehicles...

Safety belts, airbags for passengers...

Baby carriages, wheel chairs, perambulators...

Hand carts, shopping carts, one or multiple-wheeled hand carts, market cars, wheeled carriers for household goods...

Railway vehicles (locomotives, trains, tramways, railway cars, aerial cable-way, chair lifts)...

Fire arms, pump guns, spring arms and covers and suspender belts thereof...

CLASS 14

Jewelry goods (including their imitation): gold, jewels, precious stones and jewelry made from these, cuff-links, necktie brooches and statues, knickknacks ...

Watches and time measuring devices; (chronometers, metronomes (pendulums) and their parts, watch cordons)...

CLASS 15

Musical instruments and music boxes...

CLASS 16

Paper, cardboard (paperboard) and products made from these (other than stationary)...

Packaging and wrapping materials made of plastic materials...

Printed matter and bookbinding materials...

Printed documents, printed publications, calendars, posters, photographs, notices, charts, stickers, stamps...

Stationary, office, educational and teaching materials (other than furniture and devices)

Office machines...

Whitewashing and painting brushes and rolls...

CLASS 17

Rubber, gutta-percha, gum, asbestos, mica or semi-manufactured synthetic substances in form of powder, sheet, stick and folio ...

Insulation (isolation), filling and stuffing materials (including grouting, sealing, o-rings)...

Flexible pipes, hoses made of gum, plastic or rubber (including those used for vehicles), hoses

with textile pipe, cover and sleeves, fire hoses, non-metal pipe covers and sleeves, hose sleeves, radiator hoses for vehicles...

CLASS 18

Processed or unprocessed leather and hides, artificial leather, cowhide, lining leather...

Articles made of leather, imitation leather and other materials for carrying purposes not included in other classes (including bags, leather or cowhide boxes and trunks, key holders)...

Umbrellas, parasols, sun visors, walking sticks...

Whips, harness, saddlery, stirrups and saddle belts...

CLASS 19

Materials such as sand, gravels, stone chips, asphalt, pitch, cement, gypsum used for building, road construction, repairing and lining purposes...

Materials for construction, building, road construction and similar purposes manufactured and formed from concrete, gypsum, earth, clay, natural and artificial stone, wood, plastic or synthetic materials, construction elements, buildings, poles, barriers made from these movable materials (including doors and windows made of wood and synthetic materials)...

Metal, mechanic and non-luminous traffic signs for roads

Monuments, statues made of concrete, stone or marble...

Natural or synthetic surface coverings in form of layers or bands, synthetic coatings made adhered through heat; pitch covered cardboard for roofs; pitch coverings...

Glass products for construction...

Non-metal prefabricated swimming pools...

Aquarium sands...

CLASS 20

Furniture made of any kind of substances and materials, clothes-hanger (standing or stabilized)...

Bed mattresses, pillows, non-medical airbeds and pillows, sleeping bags for campers, inflatable beds...

Beehives, artificial honeycombs and honeycomb laths...

Baby carriages, playing pen (for indoors), baby chairs, baby walkers...

Plates made of wooden or synthetic materials, frames for pictures, paintings, identification cards, name bracelets, nametags, labels...

Casks, barrels, bins, storages (depots), pots, containers, boxes, trunks, safes, pallets and covers used therewith made of wooden and synthetic materials for packaging, transportation and storing purposes...

Hardware (ironmongery) articles, furniture connections, opening and closing mechanisms made of wooden and synthetic material...

Ornamental and decorative objects made of wood, wax, beeswax, plastic or gypsum...

Baskets, fisherman's baskets...

Houses, nests and beds for pets...

Transportable ladders made of wood or synthetic materials, moving staircases...

Bamboo curtains, window shade curtains, band curtains, bead curtains for decorative purposes; curtain rails, curtain rings, curtain hooks, curtain bars...

CLASS 21

Non-electric cleaning utensils (including brushes except for painting brushes, steel chips, sponges, steel wool, cleaning wool, cleaning and wiping clothes made of textile, dish-washing gloves, non-electric polishing machines, carpet brooms, mops)...

Toothbrushes, electrical toothbrushes, dental floss, shaving brushes, hair brushes, combs...

Non-electric devices for household and kitchen use included in this class, laundry pegs, pots and containers, vases (including those made of precious metals)...

Ironing boards, ironing board covers, laundry-drying mechanisms, cloth hangers...

Cages and materials for pets, plant and animal raising areas used in the household (terrariums)...

Ornamental and decorative articles made of glass, porcelain, ceramic, clay...

Mousetraps, insect traps, fly catchers, fly rackets, covers for toilet holes...

Perfume burners (burners giving off scents when lit), perfume sprays and vaporizers (atomizers); non-electric devices for removing make-up, powder puffs, boxes for toilet articles...

Spraying hose heads, heads for water sprinklers, watering apparatus, garden-watering sprinklers, tips connected to faucets...

Unprocessed glass, semi-processed glass, glass mosaics and glass powder for decorative purposes (except for construction), glass wool (not for insulation and textile purposes)...

Cups given during sports competitions...

Ropes, strings, rope ladders, hammocks, fish nets (including non-metal vehicle towing ropes)...

Tents, awnings, tarpaulins, sail canvas, automobile covers...

Packaging bags made of textile...

Synthetic fibers for textile purposes, unprocessed spun fibers, glass fibers...

Twisted yarn for textile purposes; sewing, embroidery and knitting threads, cotton threads, flexible threads...

Inner and outer clothing made from all kinds of material, except clothing for protective purposes, socks...
